Mayor Terence V. Roberts has worked in public service for more than 30 years, and he's now in his fifth term as mayor of his hometown of Anderson.

Roberts' work has spanned the spectrum, caring for displaced families to advocating for public art. He has worked with many local organizations, including the Municipal Association of South Carolina and Ten at the Top, both of which he served as president; Appalachian Council of Governments; Anderson University Board of Visitors; Salvation Army; and the Rocky River Conservancy board of directors.

As mayor, he has worked with the City Council to create public/private partnerships to revitalize downtown, which has brought restaurants, hotel development, and a municipal parking garage. He is proud that residential occupancy in downtown Anderson is nearly 100 percent.

He is working on the next phase of the city's Recreation Master Plan, which will include new trails and ball fields.
